Forms | USCIS

Visas are always available for immediate relatives of U.S. citizens. This means your family member does not need to wait in line for a visa. Immediate relatives who are in the United States can file Form I-485, Application to Register Permanent Residence or Adjust Status at the same time as Form I-130.

Online Immigrant Visa Forms—State

If applying for a family-based immigrant visa, the U.S. relative will file Form I-130, Petition for Alien Relative, on behalf of the applicant. If applying through an employer, the employer will file Form I-140, Petition for Alien Worker, on behalf of the applicant. Investors will file the I-526, Immigrant Petition by Alien Entrepreneur.

I-130, Petition for Alien Relative | USCIS

INSTRUCTIONS : APPLICATION FOR IMMIGRATION VISA AND ALIEN REGISTRATION (Form DS 230) A DS 230 form is a document used by the U.S. Department of State for immigrants who wish to permanently move to the United States. It is a required form that must be completed before any immigrant visa will be approved.

Apply for Citizenship | USCIS

Typically, relatives physically present in the United States may apply with USCIS by filing Form I-485, Application to Register Permanent Residence or Adjust Status. Typically, relatives who reside outside the United States may apply for a visa with the U.S. Department of State. For more information, please see the form instructions.

Step 3: Submit Visa Application Form—State

To be eligible to apply for an immigrant visa, a foreign citizen must be sponsored by a U.S. citizen relative, U.S. lawful permanent resident, or a prospective employer, with a few exceptions, explained below.

Application For Immigrant Visa And

After you pay your fees, you and each qualified family member immigrating with you must complete the Application for Immigrant Visa and Alien Registration (Form DS-260) in the Consular Electronic Application Center (CEAC). You may wish to preview a sample DS-260 (PDF - 6.4MB) before beginning.

Immigrant Visa—Sign In

The DS-160, Online Nonimmigrant Visa Application form, is for temporary travel to the United States, and for K (fiancé(e)) visas. Form DS-160 is submitted electronically to the Department of State website via the Internet.
