Specific servicer requirements for property preservation for loans in default are described below. ... When local ordinances/association standards differ from Fannie Mae requirements, servicers must submit a copy of the local ordinance/association standards with any bids to secure.

Note : Fannie Mae will reimburse the servicer for all property inspections when the mortgage loan is delinquent. The servicer must use a Property Inspection Report (Form 30) or its own form that provides equivalent information to document the property inspection.

The servicer must refer to the Property Preservation Matrix and Reference Guide for all maintenance work when a mortgage loan is delinquent and the property is vacant or abandoned. When the cost to complete property preservation work will exceed the Fannie Mae allowable, the servicer must submit the request via HomeTracker.
