Many practitioners believe that before filing an unlawful detainer action, the landlord must serve a "three day notice." While notice is required, many commercial leases provide various notice requirements, depending on the tenant's breach. If the landlord provides insufficient notice, it will lose the case.

Probably. California Code of Civil Procedure section 1161.1, subdivision (a) allows a landlord to include estimated amounts in a 3-day notice, if they are clearly identified as estimates (CAM charges are frequently estimated).

The Ohio three (3) day notice to quit for the nonpayment of rent, otherwise known as the "Notice to Leave the Premises," is served upon a tenant who is behind on their rent payments. The form must follow § 1923.04(a) which gives the tenant a three (3) day period to either move-out or pay the overdue amount. If they choose to do neither, they may face a legal eviction by the landlord and be forced to pay for legal fees.

Send a "3-day notice": Send a "3-day notice" to the tenant. This is a legal document that states that legal action will be taken in 3 days if the tenant continues not to pay rent or discontinue the lease agreement violation.

If a tenant fails to pay rent on time, then the landlord can give the tenant a three-day notice for failure to pay rent, or a notice similarly named. The tenant then has three days to pay the rent or leave the rental property. The three days begins on the date the notice is delivered to the tenant.

Unlike the 3-Day Pay or Quit notice, the 3-Day Quit notice doesn't offer the tenant an option to "cure" the violation. The renter must move out. ~~Eviction Notices for Nonpayment of Rent in Florida | Note~~
Three-Day Notice to Pay Rent or Quit As soon as a tenant fails to pay rent, a landlord can give the tenant a three-day notice. This notice must inform the tenant that if the tenant does not pay rent within three days of receiving the notice, then the landlord will begin eviction proceedings against the tenant (see Cal. Code of Civ. Proc. § 1161(2)).

~~Free Ohio Three (3) Day Notice to Leave Premises ...~~

If the lease's terms are silent on the issue of notice, a landlord must provide a three-day notice to a tenant prior to institution of eviction proceedings for a failure to pay rent. A landlord must also provide fifteen days' notice if the default is for a non-monetary reason.

~~3 Day Notice To Pay Rent Or Quit — Free Commercial ...~~

California commercial landlords have a choice of two types of 3-day notice for non-payment of rent: one that demands an exact amount of rent, and the other that demands an estimate of rent. 3-day notices that estimate rent are useful in situations in which it's difficult to determine the exact amount of delinquent rent, e.g. where the tenant pays percentage rent.

Serve the 3-day Notice to the tenant. If you are unable to serve the tenant personally, try leaving the notice with someone over the age of 18 at the premises and mailing an additional copy to the tenant. If this cannot be done, you can post the notice in an easily visible location at the property and mail an additional copy to the tenant.

Commercial evictions by 3-Day Notice to Quit or Non-payment of Rent in the California Code of Civil Procedure (CCP) §1161.1 allows the landlord to prepare a document called "an estimated rent demand." The landlord can estimate the amount of rent due when, for various reasons, the exact amount is not known.

~~Three Day Notice Commercial~~

The 3 Day Notice to Pay Rent or Quit commercial premises has to be issued to the leasing parties in writing. The eviction notice letter has to bear the full name of the individual, company, or organization that is leasing the property. The notice should state the address of the commercial property.
